MINUTES OF 3<sup>rd</sup> MEETING OF THE PROJECT APPRAISAL CUM CONVERGENCE COMMITTEE (PACC) FOR THE YEAR 2024-25 HELD THROUGH VC ON 25.03.2025 FOR THE 'GRANTS-IN-AID' COMPONENT OF THE SCHEME OF PRADHAN MANTRI ANUSUCHIT JAATI ABHYUDAY YOJANA (PM-AJAY)

The 3rd meeting of the Project Appraisal cum Convergence Committee (PACC) for the year 2024-25, set up under the Scheme of Pradhan Mantri Anusuchit Jaati Abhyuday Yojana (PM-AJAY) to consider the projects under the component of 'Grants in Aid for District/ State-level projects for Socio-Economic betterment of SCs' {erstwhile scheme of Special Central Assistance to Scheduled Castes Sub Plan (SCA to SCSP)}, was held through VC on 25.03.2025 at 12:30 PM under the Chairmanship of Secretary, Department of Social Justice and Empowerment. Additional Secretary (CKD) and Joint Secretary (PM-AJAY) were also present in the meeting.

- 2. As per the guidelines of the scheme of PM-AJAY, it is required for the States/Union Territories to upload their Perspective Plans (PPs) for the year 2023-24, 2024-25 and 2025-26 on PM-AJAY Portal exclusively devised for the purpose. The Perspective Plans of Uttar Pradesh and Chhattisgarh for 2024-25, 2025-26, Additional Perspective Plan of Punjab for 2024-25 were considered in the meeting.
- 3. Initiating the discussion, Additional Secretary (CKD) welcomed all the participants and Joint Secretary, PM-AJAY briefed the scheme and thereafter, with the permission of the chair, the State Governments were requested to present/ brief their projects before the PACC.

#### (A) Uttar Pradesh:

(i) The State Government of Uttar Pradesh has submitted the Perspective Plan (PP) for the years 2024-25, 2025-26 and 2026-27 under GIA component of PM-AJAY scheme. Total 110 projects have been uploaded on the portal with a total estimated cost of the project being **Rs.95,760.22 lakh** for estimated **2,36,030 SC Beneficiaries**. The State Government has submitted proposals in two interventions only viz. Income Generation and Skill Development as well as Administrative Expenses under the Scheme. The details of break-up of projects are as under:

(ii) The projects submitted by the State Govt. were discussed by the PACC and the PACC approved the projects of the year 2024-25 and 2025-26 only. The Projects of 2026-27 were not approved as the PM-AJAY Scheme is approved up to 2025-26 only.

Secretary (SJ&E) enquired about the operation of the projects to which the State replied that the projects would be implemented at the district level. It was also informed by the State that the work under GIA would be completed in six months after receipt of funds.

The following was also decided as a condition for release of funds:

- (a) The State shall develop a mechanism for timely monitoring of the progress of the Schemes from the Districts.
- (b) The State shall when submitting the utilisation certificate with regard to Skilling Component certify that the at least 70% of the trainees have either been self employed and are wage earners or have got an employment.

#### (B) Punjab:

( i ) The State Government of Punjab has submitted the additional Perspective Plan (PP) for the year 2024-25 under GIA component of PM-AJAY scheme. Total 02 projects have been uploaded on the portal with a total estimated cost of the project being **Rs.1044.63 lakh** for estimated **2000 SC Beneficiaries**. The State Government has submitted proposals in only one intervention i.e. Skill Development as well as Administrative Expenses under the Scheme. The details of break-up of projects are as under:
