MINUTES OF 2nd MEETING OF THE PROJECT APPRAISAL CUM CONVERGENCE COMMITTEE (PACC) FOR THE YEAR 2023-24 HELD ON 01.12.2023 FOR THE 'GRANTS-IN-AID' COMPONENT OF THE SCHEME OF PRADHAN MANTRI ANUSUCHIT JAATI ABHYUDAY YOJANA (PM-AJAY)

The 2nd meeting of the Project Appraisal cum Convergence Committee (PACC) for the year 2023-24, set up under the Scheme of Pradhan Mantri Anusuchit Jaati Abhyuday Yojana (PM-AJAY) to consider the projects under the component of 'Grants in Aid for District/ State-level projects for Socio-Economic betterment of SCs' was held on 01.12.2023 at 3:00 PM under the Chairmanship of Secretary, Department of Social Justice and Empowerment. Joint Secretary (PM-AJAY) and Director (PM-AJAY) were also present in the meeting. The List of representatives from States/ Union Territories and PACC members who attended the meeting is attached.

2. As per the guidelines of the scheme of PM-AJAY, it is required for the States/ Union Territories to upload their Perspective Plans (PPs) for the year 2023-24, 2024-25 and 2025-26 on PM-AJAY Portal exclusively devised for the purpose. The PPs containing project proposals of the Union Territory of **Jammu & Kashmir**, Government of **Tripura, Madhya Pradesh, Bihar, West Bengal, Kerala, Karnataka, Rajasthan, Haryana and Telanganawere** considered in the meeting. In addition, approval of the PACC was also sought for revalidation of the entire approved proposal of the State Govt. Of **Maharashtra** of Rs. 76.20 cr and releasing funds of Rs. 5.78 cr for their Annual Action Plan approved during PACC held during FY 2022-23.

3. Initiating the discussion, Secretary (SJ&E) welcomed all the participants and Joint Secretary, PM-AJAY briefed the scheme and thereafter, with the permission of the chair, the State Government/ UTs were requested to present/ brief their projects before the PACC.
