Minutes of the Project Appraisal Committee (PAC) meeting

The First meeting of the PAC setup under the Scheme of SCA to SCSP was held through online mode on 02-09-2021 at 11:00 AM to 03:00 PM. During the meeting, Annual Action Plans of the State Government of **Rajasthan, Uttar Pradesh, Uttarakhand, Tripura, Gujarat, Odisha, Assam, Punjab and Sikkim** were discussed. The AAP submitted by Madhya Pradesh could not be discussed due to some technical issue in the VC System at Bhopal.

- 2. During the meeting the AAPs submitted by the States were discussed in detail. The Secretary, DoSJE and Chairperson of the PAC directed the States to keep in mind the following broad principles while preparing the projects, finalizing the AAP and implementing the Scheme:
 - 1. For project formulation a decentralized method of planning must be used so that optimum utilization of available resources could be ensured. This will result in an increased sense of ownership for the project at District level and more attention can be given to address local needs and sustainability of the projects.
 - 2. Projects prepared by the district level authorities shall be appraised by the District Magistrate. All the projects approved by the district authorities shall come to the State Nodal Officer and further evaluated by the Principal Secretary, including the state-wide projects prepared by the State itself. The projects shall be prepared and submitted through the newly developed PMAJAY web portal which will provide a platform for end-to-end process, including for project planning. The web-portal will have a facility for assessment of these projects at Central level and a dashboard for proper monitoring of implementation of Scheme at the State as well as District level.
 - 3. Focus should be shifted to projects which could build an eco-system aimed at bringing out large number of vulnerable families of the target group from extreme poverty.
 - 4. States should adopt the new method of release of funds under the Centrally Sponsored Schemes. The information related to designation of State Nodal Agency (SNA) and opening of SNA bank account shall be communicated to the Ministry. The implementation methodology and opening of Zero Balance Subsidiary Account (ZBSA) may be expedited to ensure smooth and unhindered fund flow for implementation of projects approved under the scheme. Possibility of release of funds directly to the Implementing Agencies and necessary provision for facilitating the same maybe also be explored and incorporated in the web-portal of the scheme.
 - 5. Transparent method for identification of the beneficiaries and the partner institutions shall be adopted by the States and Districts. The details about the partner institutions involved in the implementation of Skill Development projects and particulars of the beneficiary shall be kept ready so that this data can be ported to the newly developed PMAJAY portal.
 - 6. The de-duplication of the beneficiaries amongst the intervention under the Pradhan Mantri Kaushal Vikas Yojana (PMKVY), PMDAKSH and SCA to SCSP/PMAJAY shall be ensured. For this, either the States can be given permission to use the DAKSH portal or data can be transferred between the portals for de-duplication purpose.
 - 7. The prospective beneficiaries for the skill development activities can be taken from the need assessment survey conducted in the PMAGY Villages.
 - 8. Infrastructure Development projects can also be selected from list of critical infrastructure gaps remained unfulfilled due to paucity of funds under the PMAGY.
 - 9. Prospective beneficiaries willing to join or form a Self-Help Group (SHG) can also be taken from the need assessment survey conducted under the PMAGY.
 - 10. Proper convergence with the activities being done under the SRLM shall also be ensured.
 - 11. It is learnt that self-help groups with proper track record of implementation of various schemes already have proper linkages with the banks. The self-help groups which are not bank linked, if funded under scheme, will add to the non-performing assets (NPA) for the State Channelizing Agency.
 - 12. Under the beneficiary centric projects States shall adopt Direct Benefit Transfer (DBT) method.
 - 13. While preparing the AAP, the admissible component wise limits shall be adhered too.
 - 14. While selecting the beneficiaries the States and Districts shall take care of the income limit of the families as prescribed in this scheme guidelines and the proposed subsidy shall be limited to the extent allowed under the Scheme.

- 15. If the States wish to give more subsidy than the prescribed limit, it shall give from the State's own budget or implement the scheme in convergence with the other interventions already being run by the Center or State Government or the State Channelizing Agencies of the Centre/State Schedule Caste and Finance Development Corporations.
- 3. It was pointed out by Mr. Muni Raju, representing the NITI Aayog that during the PAC meeting, the performance in respect of implementation of Schedule Caste Sub Plan (SCSP) by the State shall also be reviewed. Mr. B K Roy representing the Ministry of Skill Development and Entrepreneurship (MSDE) pointed out that for the Skill Development Activities the guidelines issued by them shall be followed. For proper planning of the Skill Development interventions and their implementations, State and District level authorities responsible for running Skill Development activities shall be consulted.
- 4. Detailed discussions about the projects submitted by the State Governments under the AAP for 2021-22 was held. The Committees' observations and decision taken on the AAP's are as under:

A. RAJASTHAN:

- a. State needs to submit the utilization certificate for the fund released under the infrastructure development component of the SCA to SCSP during 2018-19 for infrastructure development in the PMAGY villages.
- b. It also needs to submit the details about the designation of state nodal agency.
- c. The State has followed top-down approach while proposing the Annual Action Plan. The decentralized planning method needs to be adopted for taking up the meaningful and target oriented projects which can aim to improve the financial conditions of the target group.
- d. State also needs to tell how the funds will be distributed amongst the Districts.
- e. Based on the above observations and issues, the AAP submitted by the State was not approved by the Committee and the State has been further requested to submit the revised AAP before next PAC meeting which is expected to be scheduled during last week of Sept 2021.

B. UTTAR PRADESH:

- a. State's Principal Secretary informed that the SNA has already been designated and Bank Account has been opened.
- b. It committed by the State to use the unspent amount available in next 3-4 months.
- c. The State has been asked to re-do the planning exercise and limit the expenditure in proportion and extent allowed under the Scheme. Focus shall be shifted from just giving the subsidy to the beneficiaries to have the projects which can create sustainable environment for improving the economic conditions of the target population.
- d. For Skill development projects the methodology for selection of Skilling Partners and beneficiaries shall be finalized and detailed in the AAP. For infrastructure development activities, focus shall be on saturating the needs of the PMAGY Villages so that these villages can have adequate social infrastructure before declaration as Adarsh Gram.
- e. The revised AAP may be submitted by the State for appraisal by the Committee before next PAC Meeting expected to be held during last week of Sept. 2021.

C. UTTARAKHAND:

- a. Since, State is not implementing the Scheme from quite sometimes; the AAP submitted by the State is not in sync with the Scheme objectives. State has been asked to fix a training session with the District Level Authorities and call the Ministry's Team for having a session on the Scheme Guidelines and AAP preparation.
- b. State has been requested to submit the progress report in the desired formats and utilize the unspent balance in a fixed time frame so that benefit of the scheme may not get hindered to reach poor Schedule Caste population of the State.
- c. In view of above the States AAP was not accepted by the Committee. The revised AAP may be submitted for appraisal before next PAC Meeting.

D. TRIPURA:

- a. Principal Secretary of the State Mr. I. H. Dorlong apprised the committee that the SNA details have already been shared with the Ministry.
- b. It was told during the meeting that the unspent funds available with the State are already committed and will be consumed in 1-2 months.
- c. For running the skill development training activities State needs to follow the MSDE guidelines.
- d. Cost norms prescribed by MSDE shall be used for conducting the training activities.
- e. Open and transparent method of selection of beneficiaries shall be followed.
- f. The AAP submitted by the State has been approved by the committee.

E. GUJARAT:

- a. Mr. Prakash Solanki, Managing Director, State SC Development Corporation attended the PAC meeting. He apprised that the process for designation of State Nodal Agency (SNA) is under consideration with the States Finance Department.
- b. He committed that the progress report in prescribed format will be submitted during next fortnight.
- c. Committee observed that the decentralized method of the planning has not been adopted by the State while formulating the Annual Action Plan. State may come up with the detailed plan and submit the proposal through online portal. District shall be allowed to prepare and submit their plants which may be reviewed by the State and made the part of AAP.
- d. For proposed skill development activities proper method for selection of implementing agencies and beneficiaries shall be followed. Detailed projects, clearly stating the proposed stipend, remunerations to the faculty members, material cost, training cost, etc. shall be prepared.
- e. The project for setting up of computer labs in the PMAGY villages was also appraised by the committee. Concerns about the selection of beneficiaries, remuneration to the faculty, cost of consumables and other recurring expenditure was raised by the committee. The State has been advised to come up with these details. They are also required to submit that, how the optimum utilization of the resources created under the scheme (Computer Labs) will be ensured.
- Based on the above observations the State has been asked to resubmit the AAP.

F. ODISHA:

- a. Mrs. Itishree, MD, OSFDC attended the meeting of the PAC. She apprised that state has already notified the SNA and bank account has already been opened. She has been asked to submit the report to the Ministry.
- b. State has been asked to submit the plan to utilize the unspent balance which is available with State.
- c. States AAP has been approved by the committee subject to this submission of the detail about the method adopted for selection of SHG's, training partners and the beneficiaries. They are also required to submit the details about how the projects are identified and selected and what would be their larger implication on the target group.
- d. State must ensure that de-duplication of the beneficiaries between the PM-DAKSH portal and State Skilling Portal. The possibility for API based linkages with between the PM-DAKSH portal and State Skilling Portal needs to be explored.
- e. The Committee asked the State about the status of recognition of State's Skill Centers by Sector Skill Council may also be checked by the State.
- f. It is learnt that the skill development activities are being run through the skilling portal of the Odisha Government. State needs to apprise the committee about the role of the District Administration in planning, selection of beneficiaries and implementation of the skill development activities.
- g. Under the infrastructure development component, the state has demanded only Rs. 3.8 crore which is very less than the limit prescribed under the Scheme. State may come up with the additional projects for infrastructure development in the PMAGY villages so that adequate level of saturation can be achieved under the availability of social infrastructure.

G. ASSAM:

- a. Mr. M K Sahu, Principal Secretary attended the meeting of Project Appraisal Committee.
- b. He committed that the SNA details will be sent in one week of time.
- c. The unspent balance of about Rs. 30 crores available with the State will be utilized during the present financial year itself.

- d. The AAP submitted by the State has been approved by the committee subject to adoption of transparent method for selection of beneficiaries and training partners.
- e. The de-duplication of the beneficiaries between the PMKVY and the DAKSH needs to be ensured.
- f. State needs to prepare and submit the village wise details of the proposed interventions under the infrastructure component of the scheme.

H. PUNJAB:

- a. The meeting was attended by Mr Raj Bahadur, Director, Schedule Caste Welfare, Punjab Government.
- b. He apprised the committee that the State has already designated State Nodal Agency for adopting the new method of fund release.
- c. He further committed that the unspent balance available with the State will be consumed in a few months and the progress report in this regard will be submitted to the Ministry by December 2021.
- d. The Committee appraised the projects submitted by the State under various components of the Scheme.
- e. The proposal for activities proposed under State Linked Scheme 'SCA (SCSP) -2' and 'SCA (SC)-11' were not approved by the Committee. Committee pointed out that there is no need to have such projects which results in parking of funds at various levels. Under the new method of release of funds, Districts can directly draw the funds from SNA Account or have their own ZBSA. The parking of funds at the district or implementing agency level is not allowed. State may switch to new method of release of funds so that the smooth implementation of proposed interventions and just-in-time release of the funds shall be ensured.
- f. State is required to submit more details about the projects proposed through SHG Model.
- g. Committee directed the State to have more focus on the saturation of critical infrastructure needs of the Villages selected under the PMAGY. The proposal submitted for Infrastructure Development in Non-PMAGY villages was rejected by the committee. State has been advised to evaluate the Village Development Plans and identify the critical Infrastructure Gaps which remained unattended due to paucity of funds and come up with the proposal for fulfilling these critical infrastructure needs in the revised AAP.
- h. State needs to ensure the de-duplication of the beneficiaries between the PMKVY and the PM-DAKSH.

I. SIKKIM:

- a. Shri Tshwang Gyachho, Secretary, intimated that the SNA has already been designated by the State.
- b. AAP submitted by the State has been approved by the Committee subject to submission of details of the beneficiaries, implementing agencies, training partners etc.
- c. State's Notional Allocation is very less than the proposal submitted by the State. The Committee agreed to enhance the Notional Allocation, if State submits the month-wise plan of expenditure.
- d. If State has adequate capacity to utilize more than the Notional Allocation its Notional Allocation can be increased as other NER States such as Assam and Tripura already have unspent funds and may not be able to utilize this year's allocated funds.
- e. In addition to the above, the State may submit the additional projects under infrastructure development of the Scheme, if it desires so.
- 5. During the meeting some issues were also raised by Mr. C. Ramesh Rao, General Manager, NSFDC. State-wise details of the issues raised during the meeting is attached as Annexure I.
- 6. List of the Participants is enclosed as Annexure II.
- 7. The summary of the State's Annual Action Plan (Format-1-A to 1-F) is available at Annexure III.

Annexure-I

First meeting of PAC under SCA to SCSP

State-wise issues raised by the Sh. C. Ramesh Rao, General Manager (Projects), NSFDC

1.Rajasthan

- The SCA RSCSTFDCC needs to clear overdues of Rs.29.31 crore out of which Rs.6.62 crore is more than one year old overdue. Utilization level is quite low at 66.45% and the SCA needs to submit addl. UCs of Rs.26.40 crore for minimum required 80% level.
- State Government guarantee of Rs.42.45 crore is available The SCA after clearing overdues and improving Utilization can avail Rs.40 crore against fresh schemes during current financial year.
- The State has potential for Dairy, Goatery, Poultry, handicrafts, handlooms, etc. and they can support SHGs of SC women under NRLM/RSRLM.

2.Uttar Pradesh

- NSFDC rescheduled the overdues of Rs.37.68 crore in October 2015 and since then the SCA is paying Rs.4 crore yearly regularly. An overdue amount of Rs.11.08 crore still remains to be cleared. Since the SCA is regular in paying rescheduled amount, this norm can be taken as fulfilled if fresh funds are to be disbursed.
- The Finance Department, UP has been vehemently refusing to extend State Government Guarantee to UPSCFDC as the Government does not have confidence in UPSCFDC on the recovery front.
- Current year allocation is Rs.174 crore for the State. The Social Welfare Department needs to take up the matter with Finance Department to seek at least Rs.50 crore guarantee on pilot basis for quality lending in selective areas that will fetch recoveries for UPSCFDC.
- Potential opportunities are available in Goatery. NSFDC has tied up with Goat Trust Lucknow for a Goatery Cluster in Fatehpur Aspirational District. NSFDC also works with UPSRLM. Further, there is scope of Pink Piggery activities also with technical and marketing support from Export Firms promoting Pink Piggery.
- There is opportunity to set up Leather clusters with support from Central Leather Research Institute. Further, assistance of Central Institute of Medicinal & Aromatic Plants can be taken for cultivation & processing of commercial plants in the fields of small and marginal SC farmers.
- NSFDC is ready to work with UPSCFDC and other agencies for creating proof of concept and success stories in few selected livelihood sectors which can then be gradually scaled up.
- Still, if UP Government refuses to give guarantee, NSFDC can forge a tie up of UPSCFDC for credit linkage under Income Generating Activities with its RRB partners in the State namely Aryavart Bank, Lucknow, Baroda UP Gramin Bank, Gorakhpur and Prathama Bank, Moradabad.

3.Uttarakhand

- A Hilly State such as Uttarakhand requires working in mission to provide livelihood options for SC population residing in difficult areas to prevent their mass migration to the Cities.
- The State's SC population is around 19% with respect to Total State's population which is sufficiently higher than the national average.
- The State has been allocated Rs.8 crore. Surprisingly, the Finance Department of State has withdrawn Rs.18 crore guarantee which it issued earlier.
- The State has SC concentrated Districts like Pithoragarh and we need to work for livelihoods of SC population in the borders of the country.
- Scope lies in mountain goat, Dairy, backyard poultry, horticulture, floriculture, aromatic & medicinal plants, Transport Vehicles etc. NSFDC and UBVEVN can tie up with USRLM to benefit 100% SC Women SHGs in the State.

4.Tripura

• Till recently, the TSCCDC was one of the best performers under NSFDC Schemes but since the last two years they are not regular in payment of overdues leading to default amount of Rs.36 crore. NSFDC is trying to help them by rescheduling their overdues.

- The State's SC population is around 19% with respect to Total State's population which is sufficiently higher than the national average.
- Tripura a small State, has SC population of about 18% of State population which is higher than the national average. Tripura, an North Eastern State is the priority for NSFDC to expand its footprints in the NE Region.
- NSFDC has not been able to disburse funds to Tripura SCA due to overdues problem.
- Available government guarantee is Rs.10 crore.
- Potential exists in Bamboo crafts, Floriculture Dairy, Goatery, Piggery, Rubber, Poultry etc.

5.Gujarat

- The GSCDC is regularly availing funds from NSFDC but needs to scale up its lending in potential areas such as Dairy, Handlooms, Handicrafts, Protected Cultivation etc. The allocation for the State is Rs.17.11 crore for current year.
- SCA has overdue of Rs.38 crore out of which Rs.13 crore is more than one year old. The utilization level is also too low standing at roughly 70%. Government guarantee of only Rs.2.47 crore is available and additional guarantee of at least Rs.15 crore is required to cover current year's allocation.

6.0disha

- The SCA OSFDC has repaid the NSFDC dues fully. State Guarantee of about Rs.9 crore is available. The OSFDC needs to take additional guarantee of Rs.21 crore and avail its full share of allocated funds i.e. Rs.30 crore during 2021-22.
- The State's SC population is around 19% with respect to Total State's population which is sufficiently higher than the national average.
- In the coastal areas, there is concentration of SC population.
- Potential is there for Fisheries, Dairy, Poultry, Piggery etc. besides soil based schemes such as vegetable, mushroom cultivation, Power Tillers, Horticulture, Cashew cultivation. NSFDC and OSFDC can have a tieup with OSRLM for identification of credit worthy SHGs.
- If the OSFDC wants to cover SHGs not financed by Banks, it should take sufficient care to identify active SHGs following panchsootras of SHG system i.e. Regular Saving, Regular Meetings, Regular Internal Lending, Regular Recovery and Regular Book keeping.
- As far as skilling initiatives under PM-AJAY, the OSFDC should give loans to trainees in self employment oriented trades such as Plumbing, Mason, Electrician, Beauty & Wellness, Refrigeration, Hardware Shops etc.

7.Assam

- Assam is a priority State for NSFDC in the N-E Region having substantial SC population.
- The SCA has to pay overdues of Rs.7 crore out which Rs.6.23 crore is more than one year old overdue. Utilization is about 75% and Government Guarantee of about Rs.7.45 crore is available.
- Potential exists in Bamboo, Handlooms, Handicrafts, Fisheries etc.
- NSFDC and SCA can work together with the ASRLM.

8. Punjab

- Punjab has highest SC concentration and high target group population in most of its Districts. NSFDC had rescheduled the overdues of Punjab SCs Land Development and Finance Corporation during 2018-19 and since then the SCA is repaying the rescheduled amount regularly. As on date, balance overdue is Rs.9 crore.
- The State has been allocated Rs.38 crore during 2021-22. State had issued Guarantee Order for Rs.30 crore which is yet to be converted into Deed Form.
- Potential is there for Dairy, Leather, Food Processing etc.
- NSFDC would like to partner with PSCLDC in Firozpur aspirational district for livelihood activities in the PMAGY villages.
- The Punjab Government is asking for 2% guarantee commission from PSCLDFC and this fee needs to be relaxed as the projects are in the social sector. The Social Welfare Department needs to take up the matter with Finance Department for waiving the guarantee fee.

9. Sikkim

- The Sikkim SCA (SABCCO) avails funds from NSFDC regularly. NSFDC would like SABCCO to scale up funding to SC population under NSFDC Schemes.
- Potential exists in Bamboo, Piggery, Poultry, Dairy, Silver Ornaments making, Floriculture, vegetable cultivation, Transport etc.
- NSFDC has allocated Rs.0.16 lqkh during 2021-22 but SABCCO can avail funds up to Rs.1 crore if demand is there.
- There is immense potential for Singharay Goat Breed in West Sikkim District which is also the aspirational district. NSFDC can bring in its technical partner Goat Trust for goatery cluster to Sikkim.
- State Government guarantee of up to Rs.5 crore can be sought for upscaling NSFDC schemes.
