The amount is debitable to the Major Head "3601"; Grants-in-aid to State Government (Major Head); 06-Grant for State Plan Scheme (Sub Major Head); 789 Special Component Plan For Scheduled Castes (Minor Head); 34.09- Pradhan Mantri Adarsh Gram Yojana; 34.09.31-Grants-in-aid-General; Demand No.91 of the Ministry of Social Justice & Empowerment for 2019-20 (Plan).

- 4. The sanction of the above Central Assistance amounting to **Rs. 164.80 lakh** under the scheme is for undertaking the 'gap-filling' activities as well as incurring administrative expenses during the course of implementation of scheme as per the Scheme Guidelines.
- 5. The Central Assistance shall be utilized only as per the provisions and timeline envisaged scheme guidelines.
