- 3. Arrangements may please be made to credit this amount to State Government in accordance with the procedure laid down in the Ministry of Finance O.M. No. 2(45)/76 Special Cell, dated 30.8.1976, as modified vide O.M. of even number dated 16.9.76 under intimation to us.
- 4. Special Central Assistance being additive to the Scheduled Castes Sub Plan of the States/UTs should be used only for specific sector-wise schemes covering SC Population mentioned at Para 1 as per latest guidelines on the subject and approval given by the PAC.
- 5. The State Government shall furnish quarterly progress reports in respect of utilization of Special Central Assistance to the Government of India, Ministry of Social Justice & Empowerment within 15 days after the end of each quarter, in the prescribed Proforma as mentioned in the Scheme guidelines.
- 6. As per instructions contained in Ministry of Finance, Deptt. of Economic Affairs Circular No. F 2(23)-13 (CDN)/95 dated 10.2.1995 any unspent balance amount of previous year(s) cannot be carried forward for expenditure during the next financial year but will be adjusted against the amount

Coord/2008 dated 5.6.2008 no amount shall be released to any State which has defaulted in furnishing Utilizations Certificates for grants-in-aid released by the Central Government in the past.
- It is certified that no UC which is required prior to this release is pending against the 9. Government of Himachal Pradesh.
- The organization will maintain separate accounts in respect of the grants-in-aid received for this project. The accounts will remain open for inspection by the representatives or the officers from the Office of Comptroller and Auditor General of India/Government of India/concerned State Government at any time. The organization will have the accounts of the grant-in-aid audited either by the Govt. Auditor or Chartered Accountant and shall furnish the Utilization Certificate on the prescribed format i.e. GFR-12C in original duly signed by authorized signatory of the grantee organization as well as by the Chartered Accountant to this Ministry.
- The accounts will open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Office of the Ministry or Department whenever the Institution or Organization is called upon to do so.
